OLD BUSINESS

Commissioner Borsuk reviewed the inactive accounts for volunteers that didn't meet the 5 year vesting in LOSAP, and are not returning to firefighter. He confirmed with Chief Carbin the 5 firefighters. Commissioner Borsuk will terminate those accounts and return the funds back to the district, approximately \$22,000.

NEW BUSINESS

Chairman Martin shared the new election dates that have not been published, showing the date of April 20, 2021. He will post the dates on the Fire District website.

Chairman Martin discussed the need for a phone system upgrade.

The current charge is \$978/month with Verizon/Comcast
The new equipment from Blinkvoice is \$894.52/month, using same providers.

Attorney Shaklee stated the annual amount of \$10,734.24, meets the quote threshold, but not the bid threshold. He recommended receiving two more quotes, and they should have business registration certificate. Chief Carbin suggested asking if they are registered on a NJ state contract.

Chairman Martin will include for next months meeting. In addition, the reorganization meeting will not take place in March, due to election dates changing.

Chairman Martin read a thank you note from the Tamburro family, expressing their thanks to the Fire District in attending the drive through viewing for the Mayor's funeral, and thanks for all the district has done for the community and fire safety.
